CRESCENT POINT ENERGY TRUST COMPLETES ACQUISITION OF CANEX ENERGY INC.

May 30, 2006. CALGARY, ALBERTA. Crescent Point Energy Trust ("Crescent Point" or the "Trust") (TSX: CPG.UN) today closed the previously announced acquisition of Canex Energy Inc. ("Canex") for a total consideration of approximately \$85.6 million paid through a combination of Crescent Point trust units, cash and debt. Current production acquired by the Trust is approximately 975 boe/d of focused, high netback, light oil and natural gas located in northwest Alberta.

Approximately 850 boe/d of Canex's production is a consolidation with Crescent Point's core Worsley field in northwest Alberta. As a result of the transaction, Crescent Point's Worsley area production is expected to increase from 500 to 1,350 boe/d.
