CRESCENT POINT ENERGY CONFIRMS JANUARY 2013 DIVIDEND

January 15, 2013 CALGARY, ALBERTA. Crescent Point Energy Corp. ("Crescent Point" or the "Company") confirms that the cash dividend to be paid on February 15, 2013 in respect of January 2013 production, for shareholders of record on January 31, 2013 will be \$0.23 per share. The ex-dividend date is January 29, 2013.
